What is the Aldermanic Election – why vote?

The City of London C orporation is the municipal governing body of the City of London. It is the world's oldest continuously elected local government body. The Corporation's structure includes the Lord Mayor, the Court of Aldermen, the Court of Common Council and, the Freemen and Livery of the City of London. The City of London is divided into 25 wards, each of which is an electoral division. The businesses and residents of each ward form the electorate, returning, as they have done for the last millennium, one Alderman and at least two Councilmen to serve the City. The responsibilities of an Alderman are to:

- Champion and address issues raised by voters to make the City a better place to work
- Encourage businesses and entrepreneurs to set up operations in the City
- Serve as a Member of the Courts of Aldermen and Common Council on Corporation committees and related bodies, including charities such as schools:
- Support the Mayoralty and Shrievalty to promote the City of London both in the UK and internationally:
- ➤ Use the experience gained to prepare for higher office as one of the two Sheriffs of the City of London and, later, as Lord Mayor.

Foremost amongst the objectives of each Alderman is the promotion and the maintenance of the City of London as the world's leading international financial centre. The City's financial sector accounts for over 14% of GDP and is a huge contributor to the country's exports and the tax take of the Exchequer. It funds schools, hospitals and infrastructure and is of crucial importance to the UK economy.

It is the ancient rite, dating back over 1,000 years, that all those entitled to vote for Aldermen in the City of London do so — to ensure that representation is provided with the authority of the electorate. Coleman Street is one of the 25 wards that make up the City of London and is served by one Alderman and 4 Councilmen. The Ward's name emanates from coal traders who were based in this part of the City and has been home to many historical institutions, including Bethlem Hospital, now part of Bridewell Royal Hospital, a charity for disadvantaged children, which I chair.

Today Coleman Street is the home to many of the City's leading law firms, investment managers, international banks and many smaller yet equally successful businesses. It is also home to the once beautiful (and will be again after Crossrail) Finsbury Circus as well as the Institute of Chartered Accountants in England & Wales and the London Metropolitan University.
